Progress on Just Eat Takeaway.com share buyback programme 7 October – 11 October 2024

Just Eat Takeaway.com N.V. (LSE: JET, AMS: TKWY), hereinafter the “Company”, or together with its group companies “Just Eat Takeaway.com”, one of the world’s largest online food delivery marketplaces, hereby reports the transaction details related to its €150 million share buyback programme announced on 31 July 2024.

From 7 October 2024 up to and including 11 October 2024 a total of 312,812 shares were repurchased at an average price of €13.2116 on Euronext Amsterdam, a total of 78,842 shares were repurchased at an average price of €13.3185 on Cboe DXE and a total of 14,749 shares were repurchased at an average price of €13.4466 on Turquoise. Following the settlement of the above transactions, the Company will hold 6,137,585 shares in treasury.

Up to and including 11 October 2024, the total consideration for shares repurchased under this share buyback programme amounts to €39,747,695.
